Complete engine winterization includes: Replacing all lube oil and fuel filters.
Winterizing salt water side of engine cooling system. CRC engine,
All filters, Oil and Non-Tox and shop supplies are EXTRA.

- Labor per engine - \$ 550.00
- Winterize Engine only - \$ 275.00 +material
- Change Engine anti-freeze (labor only) - \$ T/M (we recommend replacing engine anti-freeze every 2 years)
- Bay Test- Mandatory with Tune up \$ 75.00
- Change transmission fluid - \$ T/M

ONBOARD SYSTEMS

- Disconnect batteries only - \$ 25.00
- Remove batteries for customer p/u - \$ 30.00
- Winterize fresh water system - \$ T/M
- Winterize ice maker - \$ 65.00
- Winterize AC units - \$ 75.00 per unit
- Winterize heads - \$ 75.00
(note holding tank must be empty or customer will be billed)
- Winterize bilge pumps - \$ 20.00 per pump
- Empty holding tank - \$100.00
- Generator oil change and filter – \$100.00 plus parts
- Dehumidification #_____ of cabins #_____ of sinks
\$ 15.00 per location (we recommend (1) Mildew bag placed in each cabin and (1) No-Damp in each sink)
- Disconnect batteries & trickle charge through winter - \$ 60 per
- Winterize shower and sump pump - \$ 45.00
- Winterize saltwater system - \$ 65.00 (wash down/baitwells)
- Winterize macerator - \$ 35.00
- Winterize washer/dryer - \$ 100.00
- Winterize holding tank -\$ 50.00 +materials
- Winterize generator - \$ 150.00 +materials
